DISTINGUISHING CHARACTERISTICS OF WORK:

This is manual work in the cleaning and performing of related duties in and around county buildings. Work involves the responsibility for cleaning and minor maintenance work in public buildings. Work is performed in accordance with established routines with specific instructions provided on non-routine tasks. Work is subject to inspection in progress and upon completion

EXAMPLES OF WORK PERFORMED:

- Sweeps, vacuums and mops
- Clean offices; dust and empty waste baskets
- Clean and sanitize restrooms and replenished supplies
- Clean walls, partitions, ceilings and woodwork
- Clean interior windows and mirrors
- Monitor and maintain stock of cleaning supplies
- Follow and complete daily, weekly and monthly cleaning forms and schedules
- Place garbage in closed dumpsters provided in the cleaning areas
- Clean and disinfect trash cans and change trash bags
- Wash and sanitize bathroom fixtures, doors and door handles
- Perform other cleaning duties as specified on schedule
- Refill paper towels, toilet paper, air fresheners and soap in all dispensers; checking batteries for proper working order
- Operate heavy cleaning equipment such as scrubbing machines, high speed buffers, carpet shampoos or wet/dry vacuum machines
- Report to Supervisors the presence of animals, vermin, insects, water leaks, maintenance needs, when in need of cleaning supplies, equipment repairs and all other health and safety hazards observed
- Attend and participate in department in-service training
- Performs any other duties as assigned by supervisors

- Skill in the use and care of custodial equipment.
- Ability to establish and maintain effective working relationships with the general public, co-workers, elected and appointed officials and members of diverse cultural and linguistic backgrounds regardless of race, religion, age, sex, disability or political affiliation.

QUALIFICATIONS:

- Possess and maintain a valid Florida driver license
- Experience in commercial cleaning or any equivalent combination of training and experience.
- High School Diploma or GED.

PHYSICAL REQUIREMENTS:

- Ability to see and hear (with or without corrective devices).
- Ability to reach, stand, walk, stoop and bend.
- Ability to lift and/or move 50 to 100 pounds.
- Ability to drive county vehicle to and from work sites.
- This job involves standing for long periods as well as stooping squatting, lifting, carrying, pushing and pulling.
- Must be able to work flexible schedule; some nights and weekends.
- Must be able to lift, load and unload floor cleaning machines into county vehicles without assistance.
- Exposure to adverse weather conditions.
- Possible exposure to blood, bodily fluids or communicable diseases.
- Wearing of protective equipment, such as latex gloves is required.
